## DATA PRIVACY NOTICE

Information requirements according to Art. 13 and Art. 14 GDPR

Protecting your privacy is for us, United Freight GmbH great concern, therefore we will process your personal data on the basis of the Austrian Data Processing Act and the EU General Data Protection Regulation, which enters into force on 25 May 2018.

### 1. Collection and processing of personal data

Following data categories will be processed:

- Name data, e.g. first name, surname, username, etc.
- Personal data, e.g. age, gender, date of birth, nationality, role within the company, ID copies, etc.
- Contact data, e.g. address, telephone number, e-mail address, etc
- Identification data, e.g. personal ID card number, passport number, customer number, etc.
- Official data, e.g. reference number, tax number, attachment of salary, tenant pass (Germany)
- Bank data, e.g. account number, information on creditworthiness, etc.
- Vehicle data, e.g. vehicle number, chassis number, engine number, registration plate, registration certificate, fuel card, forklift license information, etc.

If you contact us using the form on the website or by e-mail, we will store the data you provide for 6 months for the purpose of the processing the request and in case of follow-up questions. We do not share this data without your permission.

## 3. Purposes of the data processing

We process your personal data for the following purposes:

- fulfilment of existing contracts on our products and services
- processing offers and inquiries to United Freight GmbH, including the creation of offers for contracts on our products and services
- Assessment of suitability as a contractual partner, e.g. credit checks on potential customers, suppliers, etc.
- Handling our contractual and business relationships, e.g. execution of transports and deliveries, accounting, dunning, handling complaints and claims, quality management, processing our purchasing etc.
- Provision and administration of insurance, handling of claims

## 4. Legal basis of processing

Legal bases for our processing of your data are:

- Austrian Data Protection Act

## 5. Transmission of personal data

For the purpose of providing our contract your personal data can be forwarded to the following people: Third parties employed by us e.g. IT service providers, persons in a business relationship with us, e.g. customers, transport partners, suppliers, recipients of the delivery and Public bodies, e.g. customs offices.

In some cases it may be necessary to forward data also to recipients outside Austria and outside of the European Economic Area. In these countries there is a lower level of data protection than in the European Union. In this case, however, we ensure that suitable privacy safeguards are in place.

## 6. Storage period

Your personal data will only be stored by United Freight GmbH for as long as is reasonably necessary to achieve the aforementioned purposes. We also store your personal data for as long as there are statutory retention obligations or limitation periods for potential legal claims have not yet expired.

## 7. Right to information and right of revocation

You generally have the rights to verification, rectification, deletion, restriction, data portability, revocation and objection.

## 8. Cookies

Our website uses cookies. These are small text files that are stored on your device using your browser. They do no harm your computer.

We use cookies to make our website user-friendly. Some cookies remain stored on your device until you delete them. They enable us to recognize your browser next time you visit the website.
